MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

DEPARTMENT OF ECONOMICS, SIBSAGAR GIRLS' COLLEGE, SIVASAGAR

AND

DEPARTMENT OF ECONOMICS, SONARI COLLEGE, SONARI

This Memorandum of Understanding (MoU) is made on 29th December, 2021 between Department of Economics, Sibsagar Girls' College, Sivasagar, 785640, Assam, hereafter referred the 'Department of Economics, SGC)

and

Department of Economics, Sonari College, located at Sonari, Charaideo, 785690, hereafter referred as 'Department of Economics, SC). The aforesaid departments are hereinafter referred to individually as party and collectively as parties.

Objectives of the MoU

The MoU is entered with the following objectives

1. To promote and enhance academic interest between SGC and SC.
2. To provide an atmosphere of sharing expertise and knowledge among the students and the faculties between the two Parties.

Areas of Collaboration

Department of Economics, SGC and Department of Economics, SC hereby agree to encourage academic cooperation through faculty exchange in furtherance of the advancement of teaching and learning as stated below:

- (a) To encourage visits by faculty from one college to the other for the purpose of teaching.
- (b) To encourage visits of students from one college to the other for the purpose of learning.
- (c) To facilitate the sharing of academic materials.
- (d) To promote other academic activities which enhance the above mentioned goals.
- (e) To foster collaboration in organizing academic seminars, workshops etc.

Duration

Both the colleges agree to review this MoU after five (5) years following the date of signing and also acknowledge that this MoU is subject to revision and termination at any time by mutual consent or by 90 days written notice by either college.

Coordinators

Both parties will designate persons who will have responsibility for coordination and implementation of this agreement.

Rights

Both parties will honour their individual rights in performing their day to day academic activities. The collaborative activities under this agreement will be worked out on a case to case basis without deferring the intellectual property rights (IPR) of both the parties.
