The assessment of Program Outcomes (POs) and Program Specific Outcomes (PSOs) is conducted through both direct and indirect methods, aligned with course outcomes. Direct methods include university exams, internal exams, and assignments, where course outcomes are mapped to specific problems. Two internal tests per semester evaluate student competencies and the achievement of corresponding course outcomes (COs). Assignments and seminars at the end of each module help reinforce learning through textbooks and reference materials.

Indirect methods include alumni and employer surveys, conducted annually. The alumni survey assesses the relevance of the curriculum and its alignment with industry skills, while the employer survey evaluates whether the knowledge and skills gained meet industry expectations. The student exit survey, conducted once a year, helps identify strengths, weaknesses, and areas for future improvement, including the effectiveness of value-added courses and pre-placement training. The Program Assessment Committee uses these results to assess the attainment of POs and PSOs.






Number of Students gaining Admissions to higher Courses-
